LRPC Executive Board Meeting Minutes of March 8, 2023

1. Call to Order

Chair Ayer called the meeting to order at 9:04 AM noting that a quorum was present, and that Vice Chair Dave Katz was joining us remotely. Vice Chair Katz stated that he was alone in the room.

2. Minutes

Minutes of November's Executive Board meeting were acknowledged for comments and discussion. Following same, Secretary Pat Farley put forth a motion to accept the minutes as presented which was seconded by Mardean Badger. A voice vote was taken in which all members present were in favor (including Vice Chair Katz) with the exception of Bill Bolton who abstained. Motion passed.

Minutes of December's Executive Board meeting was acknowledged for comments and discussion. Following same, Cristina Ashjian put forth a motion to accept the minutes as presented which was seconded by Secretary Pat Farley. A voice vote was taken in which all members present were in favor (including Vice Chair Katz) with the exception of Bill Bolton who abstained. Motion passed.

3. Finance/Treasurer Report

Executive Director Hayes noted that there still remains a bit of a deficit. Some of this is due to an increase in staff and benefits as well as some projects that have gone over budget a bit. We are expecting to recover soon as projects are wrapping up.

4. **Monthly Executive Report** (December, January, February)

Executive Director Hayes provided a brief review of these reports. There were some questions and discussions on various items.

5. Committee Reports (TAC)

Treasurer Kerr advised that March's meeting was cancelled. February's meeting saw a coordinated interest in the bike/pedestrian plan. Traffic counts were discussed. Moultonborough would like to consolidate 4 of their TYP projects into one as these 4 are related to intersections within the same general geographic area. Undertaking these projects during the same timeframe would be less disruptive to traffic flow. Also Bristol is experiencing funding issues regarding 2 of their projects and they are trying to decide how best to handle this.

6. Old Business

- a. RHNA Report Fair Share Housing Allocation by Town. Executive Director Hayes explained that he will be presenting the draft RHNA report to the full commission at the Commission Meeting scheduled for end of the month. Fair share allocation is the main concern. Municipalities should be looking at their Master Plans with a view towards finding a location in the community where high density makes sense. There is a serious legal obligation to comply with these numbers. LRPC will be implementing a greater effort to look at water and sewer capacity issues in communities which is a barrier to allow for increased density in order to meet these requirements.
- b. <u>By-Law Change</u>. Executive Director Hayes reviewed the proposed change which will align our By-Laws with RSA 36 regarding annual election of officers. Vice Chair Katz suggested that it be modified further to reflect that commissioners are responsible for electing both the Executive Board and its officers as it appeared to be unclear in his view. This suggestion was undisputed and will be followed-up on at the next Board meeting, placed on the agenda under "old business".
- c. <u>Name Tags</u>. Reminder was made. Most important to be worn at the Commissioner meetings in order to identify commissioners from non-commissioner attendees, especially when it comes to voting.

7. New Business

- a. <u>SB-47</u>. Executive Director Hayes commented that he wanted Board members to be aware of bill and to stress that density is one of the main components being focused on to address the current housing shortage.
- b. <u>LRPC Member Logo</u>. Chair Ayer voiced his thoughts on creating this logo for use by municipalities in their outgoing communications. There will be further discussion and consideration at a future date with examples.
- d. Resignations/Open Board Positions. Executive Director Hayes announced that in addition to the current vacant board position, we will be losing another member as Steve Wingate will be stepping down at the conclusion of his term. While the Chair is permitted to appoint a temporary replacement prior to elections, we do need to be thinking about full term candidates for placement on the ballot for the annual meeting. Discussion was had regarding whether or not to reduce the board membership down from 12. This is primarily due to difficulties in finding interested replacements and attendance issues to establish quorums. It was decided to continue the discussion at the next meeting.
- e. Commitment to Serve & Conflict of Interest Policies **for Commissioners**. Executive Director Hayes described the need to have not only Executive Board members, but also Commissioners sign these two documents. A separate version of these documents was created for Commissioners where their duties vary from those of Executive Board members. Executive Director Hayes asked that the Board readopt these policies so we can distribute them to Commissioners for signature. Chair Ayer noted that in the Commitment to Serve for Board Members document there was reference to the Board as "Board of Directors" rather than "Executive Board". It was suggested that, although we are commonly referred to as a Board of Directors, we should change the verbiage in the policy documents to "Executive Board" where necessary to be consistent with the identification of the board in the By-Laws. Vice Chair Katz proffered a motion to adopt the policies with suggested amendments which was seconded by Treasurer Kerr. There was no further discussion. A voice vote taken indicated all were in favor (including Vice Chair Katz). Motion passed.

- f. Annual Meeting Nominating Committee. The Nominating Committee consists of Executive Director Hayes, Chair Ayer, and Vice Chair Katz. The Committee will work on the ballot for the annual meeting to fill the current vacant position and the upcoming vacant position on the Executive Board should it be decided that we continue with 12 members. Annual officer nominations will need to be included on the ballot as well.

 Annual Meeting Awards Committee. The Awards Committee consists of Bob Snelling and Dean Anson.
- g. Approval of TYP Priorities. Sr. Transportation Planner, Sean Chamberlin, informed the Board that he has at long last received feedback from the DOT on the priority list submitted back in November. As such, it is now the TAC's recommendation that, with the allocation we have received from DOT, we increase the funding for the Meredith intersection project as first priority and, with the remaining funds, partially fund the Laconia rehabilitation project as second priority. Additionally, information being received regarding TYP projects currently entering the engineering phase is that costs are significantly higher than expected when they entered the plan. Sean posits that over the next two or more rounds of TYP, that we should look to reinvest in these existing projects rather than submit new ones. Vice Chair Katz put forth a motion to approve the TAC's proposed recommendation for the TYP be submitted to DOT. Treasurer Kerr seconded the motion. No further discussion. A voice vote was conducted with all in favor. Motion passed.

8. Announcements

Executive Director Hayes wanted everyone to be aware of the congressional ear mark requests being accepted by Senator Shaheen and Congressman Pappas. He also advised that he and Sean recently met with Executive Councilor Warmington who was looking to better understand our TYP priorities. A copy of a recent Governor and Executive Council Meeting Report is included in the meeting packet. Additionally, Executive Director Hayes announced that there will be a NH Association of Regional Planning Commissions (NHARPC) Commissioners Convening lunch meeting on May 5, 2023 if anyone would like to attend.

9. Roundtable

S. Wingate, Tuftonboro—A couple of years ago, the LRPC assisted the town in obtaining a grant to build a new police station. As it turns out, the cost of the build has been more expensive than they had counted on so there is a plan to construct only 76% of the building which still needs to be approved at the town meeting. The building has been redesigned such that it can be added on to in the future.

Pat Farley, Tamworth—The town recently hosted a broadband forum to educate the public on the available options and costs. Consolidated Communications received the award. They are currently waiting for the engineers to do their part. The town's septic system (in the center of town) is at capacity which prohibits any new development or expansions. There have been discussions regarding the construction of a new system. The selectboard sent out a letter of request to engineers to explore this, but have not received any responses as of yet.

C. Ashjian, Moultonborough—In February the planning board approved the application of costs developers for the Bean Road housing development despite abutters disapproval. It has, however, been scaled down to 42 market-rate duplex units. Cristina also attended the Meredith DOT meeting regarding the historic culvert replacement project. There has been a new presentation to the selectboard relative to creating a Community Center.

D. Katz, New Hampton—Dave has been doing some commissioner recruiting and announced that he has found someone to fill the vacant Commissioner position in New Hampton; waiting on the selectboard to make the appointment. He suggested that if other commissioners could follow suit and assist in filling vacant spots, it would

certainly help with our quorum issues. The condition assessment has been completed relative to the rehabilitation of the 1798 Town House and the report has been posted to the town's website for anyone interested in reviewing it.

D. Anson, Laconia—Reporting on conservation issues, Dean advised that the Winnisquam Watershed Network has been able to secure 319 grant funds to work on improvements along the shoreline of Winnisquam. The grant money will help to address run off issues from Black Brook Road in Sanbornton, Deer Park Association in Meredith, and Gale Avenue in Laconia. They are waiting for the engineering selection process to begin. Also, there was a joint meeting between the Laconia and Gilford Conservation Commissions looking to combine resources to identify overlapping projects to address.

B. Bolton, Plymouth—The Ways & Means Committee is considering the pot bill coming down the line. The town is looking at a joint community center which would include housing the police and fire stations. It seems as though there are a lot more items being put on as warrant articles for town meeting. Bill notes that there seems to be some difficulty in maintaining a good relationship between non-profits and for-profits in Plymouth and the town is suffering under the weight of supporting this. A bill was put in this year to establish a commission to look at the nature of non-profits, but adoption is doubtful. They likely will need to increase the tax load to compensate.

M. Badger, Ashland—There is one amendment on the ballot for revisions of the flood hazard area language which came through FEMA for planning and zoning. There are two warrants on the ballot which came from the selectboard, one is for a trash-to-energy facility and the other is for broadband access. The Mill Pond development proposal is currently at a standstill with regard to information going through the planning board. If it does get approved, it would meet the requirements for affordable housing. There is an old subdivision development which was approved back in the 80's made up of multiple parcels which has not had any activity since its approval. Subsequently, some parcels of the overall property have changed hands. There have been a couple of recommendations to the selectboard in the past to revoke the approval on those grounds. The planning board has referred the matter to the selectboard with a request that they hire legal council to sort it out.

D. Kerr, Barnstead—Town elections are next Tuesday. The planning board has one vacancy with one candidate running. That person is also interested in becoming a second commissioner. To add to the difficulties with regard to the ongoing subdivision matter, the developer was supposed to set up a fund to cover for the town's costs of any legal fees or special studies needed to be done, but the money was never deposited so collection might be contentious.

J. Ayer, Gilford—Town meeting is next week. Gilford has settled on a short-term rental ordinance which will be voted on at town meeting. If approved, staff will need to figure out how to implement this for discussion with the planning board. They are also in the process of amending their steep slopes regulations.



PROPOSED BY-LAW CHANGES

8.3 Nomination of Executive Board & Officers

A Nominating Committee of up to five (5) Commissioners shall be appointed by the Executive Board of the Commission at least one hundred eighty (180) days in advance of the Annual Commission meeting. The Nominating Committee shall consider the interest, ability, and residency of Commissioner members in serving as members of the Executive Board. The Nominating Committee shall also be responsible for nominating Executive Board officers from the Executive Board members. This information shall be used in preparing a ballot to be submitted to the Commission. The Nominating Committee may nominate one or more candidates for each office.

8.4 Election of Executive Board & Officers

The Executive Board shall be elected by the affirmative written ballots of a majority of the Commissioners voting at the Annual Meeting every two (2) years. Executive Board officers shall be elected by the affirmative written ballots of a majority of the Commissioners voting at the Annual Meeting every year (annually). The results of the ballots shall be totaled and announced at that meeting. Commissioners are privileged to vote for any qualified person, whether or not he that person be nominated by the Nominating Committee. In case no candidate for a particular office shall receive a majority of the votes cast, a second ballot shall be cast between the two candidates with the most votes. Then, in the event of a tie, the office will be determined by lot.

9.8 Electronic Participation in Meetings

The Lakes Region Planning Commission, its Executive Committee Board, Transportation Technical Advisory Committee and any other committee or sub-committee that may be established shall allow one or more members of those bodies to participate in a meeting by electronic means of communication for the benefit of the public and the specific committee subject to the provisions of RSA 91-A:2, III.

Except in cases of emergency as defined in RSA 91-A: 2, III (b), a quorum of the Commission, Executive CommitteeBoard, Technical Advisory Committee or any other committee or sub-committee shall be physically present at the location specified in the meeting notice as the location of the meeting.

LRPC submitted our list of initial priorities approved by our Executive Board to NHDOT on November 10, 2022. We received comments from NHDOT on those projects on February 22, 2023. The comments were sent out to the applicants to review and address as they determined. After reviewing NHDOT's comments and further discussion with the City of Laconia it was determined that the Union Ave project that had originally been proposed as priority three should be moved up to priority. This reflects how the TAC scored projects after our November meeting. The Union Ave project was moved down to third due to concerns raised by NHDOT at the time of the initial submission. Those concerns seemed to be addressed in the February comments.

At its meeting on March 8, 2023, the Lakes Region Planning Commission's Executive Board voted to approve submission of the following Ten-Year Transportation Plan priorities for 2025-2034:

- 1. NH 25 Meredith Increase allocation to NHDOT Project #43533 by \$2,981,808.
- 2. **US 3 Union Ave Laconia** Road rehabilitation and pedestrian safety improvements from NH 106 to NH 11A; Project estimate: \$3,923,122 (80% of the \$4,903,903 total)
- 3. **US 3 N. Main St Plymouth** Sightline and pedestrian improvements; project estimate: \$7,411,102

We recognize that project priorities 1 & 2 exceed LRPC's 2025 – 2034 allocation by \$714,277, committing that amount to our 2027 allocation.

Project priority 3 to be considered for additional allocation if available.

Thank you for your assistance throughout the Ten-Year Plan process.

NHDOT PROJECT REVIEW COMMITTEE SUMMARY RECOMMENDATIONS FOR PROJECTS PROPOSED BY LAKES REGION PLANNING COMMISSION FOR THE 2025-2034 NH TEN YEAR TRANSPORTATION PLAN

Initial Priority #1: Intersection improvements at 4 intersections with NH 25 (Meredith)

Project summary: This proposal allocates additional funding for the Meredith 43533 project involving improvements to 4 intersections of local roads with NH 25. These intersections were previously commented on in detail as part of the 2023-2032 Ten Year Plan comments.

Review Comments

All prior comments related to the 2023-2032 Ten Year Plan remain valid. The focus of this allocation is to address the underfunded concerns raised previously.

Review Summary

- The project is recommended to remain as currently programmed in the 2023-20332 TYP with PE in 2027, with ROW planned in 2030 and CON beginning in 2032
- The proposed project would add an additional \$2,981,808 (delta between 2023-2032 value and the increased 2025-2034 TYP value that considers 3.7%/yr. inflation and 10% for NHDOT indirect costs) of the regional allocation for the 2025-2034 Ten Year Transportation Plan.
- The proposed increase to this project would utilize \$2,981,808 of the LRPC's 2025-2034 TYP allocation.
- The project will continue to be 100% federal funds with Turnpike Toll Credit Match.

The table below provides the cost estimate details from NHDOT's project review efforts related to the **2023-2032** Ten Year Plan:

Initial Priority #2: North Main St. multimodal safety improvements (Plymouth)

Project summary: The purpose of this project is to improve sight distance and provide pedestrian access by correcting poor road alignment (both vertical and horizontal) and a lack of pedestrian infrastructure on Main Street (US-3) north of Tobey Road to Fairgrounds Road.

Review Comments

- The NHDOT reviewers commented that for the portion of the project from Tobey Road to River Bridge, the plans appear to consider full depth reconstruction with vertical and horizontal alignment adjustments. However, the plan presented is confusing as to what is proposed and alignment vertical adjustments don't appear correct.
- The NHDOT reviewers noted that the portion of the project from the river bridge to Fairground Road, the project appears to be solely focused on sidewalk construction only.
- Reviewers note that while the project passes over it, there is no mention of work to the truss bridge over the Baker River.
- The proposed project goes by and involves work at the termini of the US3/NH25 interchange ramps, but no mention of any work to these ramps is proposed (except sidewalks/crosswalks).
- The conceptual plans show adding a sidewalk to the west side of US 3 bridge over NH25. However there does not appear to be a connecting sidewalk currently.
- Reviewers questioned whether the proposal involves reallocating existing shoulder width or adding the sidewalk to the bridge.
- Reviewers noted that there is an existing sidewalk on the west side of the US 3 bridge but no sidewalks leading up to the bridge on either end.
- Reviewers noted that if the proposal involves use of the existing shoulder, then additional design efforts involving joint work, structural analysis, loading, etc. would be necessary.
- Reviewers questioned whether there were any proposed impacts to the Railroad as it appears that moving the road and adjusting the profile towards the railroad will cause impacts to the railroad property.
- If sidewalks will be constructed, the Town will need to execute a Municipal Agreement acknowledging maintenance obligations once the project is constructed.

Review Summary

- The project is recommended to commence with PE in 2030, ROW in 2032 and CON in 2034.
- The proposed project would use **\$7,411,102** of the regional allocation for the 2025-2034 Ten Year Transportation Plan.
- The Year-of-Expenditure (YoE) values include inflation of 3.7%/year and indirect costs of 10%.
- The project will be 100% federal funds with Turnpike Toll Credit (TTC) match.

Initial Priority #3: Route 107 rehabilitation (Laconia)

Project summary: The purpose of this project is to rehabilitate this heavily travelled and populated downtown corridor in the lakes region. The rehabilitation will involve replacing underground utilities including stormwater/drainage infrastructure, pavement and subbase improvements, pedestrian accessibility, traffic and pedestrian signals, and streetscape and lighting.

Review Comments

- Project would be funded with 80% Federal Aid program funding and 20% City match.
- NHDOT reviewers noted that the design is identified as 90% complete in the submittal, so it was assumed that no additional PE is needed.
- NHDOT review notes no included ROW budget amount, so the project cost discussion assumes the City will acquire or has acquired all ROW needs without federal funds participation/prior to commencing the proposed TYP project.
 - o This is important to note given that NHDOT reviewers noted the presence of physical structures right up against the observed ROW (retaining walls, buildings up against the sidewalk, etc..) which will make for limited construction access absent additional ROW/easement acquisitions.
- There are sewer line improvements shown that would be non-participating costs (100% City costs) so this will reduce the total construction cost impact to the Ten-Year Plan.
- NHDOT reviewers noted the presence of utility poles in the sidewalk in multiple locations under current conditions. It was unclear from the scope discussion re: "includes underground utility improvements" whether that means just drainage or public utilities (electric, cable, etc.) are being put underground. NHDOT review notes that this would be both an expensive option and not a federal-aid-eligible expense (utilities).
- NHDOT review comments noted a reminder that when you receive federal funds stricter environmental permitting requirements will become part of the project.

Review Summary

- Values presented below represent the project commencing with CON in 2034.
- The Year-of-Expenditure (YoE) values include inflation of 3.7%/year.
- The project would utilize \$3,923,122 (80% of the \$4,903,903 total) of LRPC's 2025-2034 Ten Year Transportation Plan funding allocation.
- Water and sewer related costs were not included in the values below as they were not considered to be federal
 aid eligible.
- The City of Laconia would be responsible for the \$980,780 match (20%)
- The project would be administered as a Local Public Agency (LPA) project managed and match funded by the City of Laconia.
- A Municipal Agreement would need to be executed to govern the prosecution of the project and to outline maintenance obligations once the project is complete.
- The funding breakdown for the project as estimated:
 \$3,923,122 (federal funds) +\$980,780 (City of Laconia) = \$4,903,903 (total project)
- The Department is concerned that there are no funds allocated to ROW even though there is the presence of physical structures right up against the observed ROW (retaining walls, buildings up against the sidewalk, etc.) If this project is put forward by LRPC for inclusion in the Ten-Year Plan there will need to be further discussion and agreement between the Department, LRPC and City if additional funding will be requested. Not including appropriate funding at this time puts additional funding at risk later.

The Lakes Region Planning Commission (LRPC) has requested HEB Engineers, Inc. (HEB) investigate and provide costs associated for multi-modal improvements on US-3 (Main Street) from Tobey Road to Fairgrounds Road in Plymouth, New Hampshire (see Project Location Plan in Attachment A). The purpose is to provide conceptual drawings with associated cost estimates for consideration of adding improvements at this location to the NHDOT Ten Year Plan (TYP).

HEB reviewed the Transportation Project Proposal prepared by the Town of Plymouth, conducted a field review of the project site, and attended a meeting with Town Officials and Public Works staff to discuss on-going safety concerns. HEB evaluated all the information provided and presented concept drawings and project costs to the LRPC Transportation Technical Advisory Committee (TAC) for improvements on US-3 between Tobey Road and Fairgrounds Road in Plymouth. Below is a summary of our findings.

Existing Conditions

US-3 (Main Street) from Tobey Road to Fairgrounds Road is a north/south, two-lane, rural major collector highway. It is a non-NHS route, with a posted speed limit of 30 mph which changes to 40 mph in the vicinity of Armory Road. The 2019 Annual Average Daily Traffic of 4,161 vehicles per day. NHDOT collected more recent traffic data in May 2022; however, updated AADT values are currently unavailable.

The project area includes a number of anchor businesses and employers within downtown Plymouth, as well as sites that present opportunities for future economic development. Plymouth benefits from an outdoor recreation economy; however, there is no pedestrian or bicycle infrastructure within the project area to provide connectivity to key businesses and existing destinations.

Pedestrian Infrastructure

There are narrow shoulders and no sidewalks along US-3 within the project limits. "Herd paths" were observed along much of the roadway corridor, presenting evidence of pedestrian traffic utilizing the roadside instead of the shoulder.

Plymouth State University has student housing and commuter parking along this stretch of Main Street, with university buildings located to the south, requiring students to walk or bike to classes along US-3. This creates safety concerns for students walking between classes, housing, and the commuter lot.

There is affordable housing on Fairgrounds Road; however, there is no pedestrian connection from Fairgrounds Road to downtown Plymouth businesses; approximately 0.7 miles. Residents in affordable housing communities may be less likely to have access to a personal motor vehicle and may require public transportation or non-motorized modes to get around. Non-motorized users are disproportionately affected by motor vehicle crashes. Nation-wide pedestrian fatalities are trending in the wrong direction. NHDOT's 2022 Strategic Highway Safety Plan indicates that over the past 5 years pedestrian fatalities have increased over 20%.

Bicycle Infrastructure

US-3 has a narrow roadway section, approximately 26 feet wide near Tobey Road. It widens slightly towards the Baker River, but generally paved shoulders are between 1 – 2 feet wide. During the field review, multiple bicyclists were observed riding within the project limits. The observed cyclists were all from the Mt. Prospect Academy; which is approximately 0.25 miles north of Fairgrounds Road. Outdoor recreation is part of their regular program. There is a bicycle shop on Foster Street, and the Town of Plymouth has plans to include a recreational trail connection from Main Street to the Langdon Woods trails along the Baker River as part of a budgeted sewer project.

There are wider shoulders north of Foster Street. Recent re-striping reduced the 3-lane section between the Tenney Mountain Highway ramps to a 2-lane section with wider shoulders and a painted median.

Roadway

The New Hampshire Army National Guard has a facility located on Armory Road. Due to limited sight distance the National Guard has truck deliveries utilize a right-in/right-out commuting pattern. Although this delivery practice is safer, it increases fuel consumption and creates unnecessary motor vehicle delay. Intersection sight distance (ISD) was measured during the site walk to be approximately 273 feet, which would be inadequate for a passenger car design speed of 25 mph and inadequate for a single-unit truck design speed of 20 mph. The posted speed limit on US-3 at Armory Road is 40 mph. In reviewing the vertical geometry, HEB believes that the stopping sight distance along this vertical curve is also sub-standard for the roadway (approximated from available LiDAR).

Proposed Project Scope

The purpose of this project is to improve safety for motorized and non-motorized traffic along US-3 (Main Street) between Tobey Road and Fairgrounds Road in Plymouth, NH. Safety improvements for motorized traffic pertain to sub-standard sight distances in the vicinity of Armory Road. Safety improvements for non-motorized traffic include the addition of bicycle and pedestrian facilities within the project limits.

At the Town's request the project was scoped in two phases. Phase 1 includes all roadway work and pedestrian connectivity from Tobey Road to Foster Street. Phase 2 extends the pedestrian connection from Foster Street to Fairgrounds Road. Please see the concept drawings in Attachment B. Below is a narrative that discusses the proposed improvements shown on the concept drawings.

Phase 1: US-3 from Tobey Road to Foster Street

There is a significant need for non-motorized infrastructure within the project limits. The proposed project scope would include a 5-foot concrete sidewalk along the west side of US-3. The sidewalk would tie in to the existing sidewalk at Tobey Road then continue north to the Baker River Bridge, where there is an existing 5-foot-wide pedestrian walkway across the west side of the bridge. The 5-foot concrete sidewalk would continue on the other side of the Baker River and cross the eastbound ramps for the Tenney Mountain Highway, to a proposed pedestrian crossing on US-3 to Foster Street. This would provide connectivity from downtown Plymouth, along university housing and parking, and terminate at a destination. At the request of the Town, a 4-foot grass buffer strip, also known as a snow shelf, is planned between the sidewalk and the roadway. The snow shelf provides room for snow storage for winter maintenance and additional separation of facilities for pedestrian safety.

Based on observed bicycle traffic, an established bicycle shop on Foster Street, and a future planned trail connection from US-3 to the Langdon Woods recreational trails, it is recommended to add 5-foot-wide shoulders on both sides of US-3 for enhanced bicycle accommodation. This will provide dedicated space for bicyclists, which will enhance safety and use, as well as create additional opportunities for recreation from downtown.

Lakes Region Planning Commission Plymouth US-3 Memorandum: NHDOT TYP Scoping HEB Project #2022-105

US-3 between Tobey Road and Old Main Street should be reconstructed to meet geometric standards. This work would include correcting the crest vertical curve between Tobey Road and Armory Road to provide SSD that meets design guidance and ISD for truck traffic on Armory Road. This work will result in a large retaining wall near the crest of the vertical curve, to eliminate grading impacts to university parking. It is recommended to shift the alignment of US-3 horizontally away from the parking lot to minimize the size of the retaining wall.

The addition of curbing on the west side of US-3 will require extending the contained drainage system. There is an existing Town maintained system near Tobey Road. For drainage towards Tobey Road, there is a plan to add two additional basins to the existing system. On the Armory Road side of the crest vertical curve, a new State maintained contained drainage system will need to be installed. US-3 is superelevated through the Armory Road intersection, so it is anticipated only two basins would be needed through the sag vertical curve approaching the Baker River Bridge. This system may require a drainage easement to outlet to the west in the vegetated area.

Additional consideration of an appropriate design speed should be investigated in the Preliminary Engineering phase. For scoping purposes, HEB utilized a design speed of 40 mph; however, as land use continues to develop in this area, it could become an extension of the downtown corridor. The anticipated change in land use paired with the addition of multi-modal infrastructure warrants an engineering study to determine an appropriate speed limit and design speed for US-3 in this area. It seems with an increased focus on non-motorized modes within the project limits, reducing speeds should be considered and could ultimately affect the level of geometric improvement at this location.

Phase 2: US-3 from Foster Street to Fairgrounds Road

The proposed project scope for this phase is a continuation of the sidewalk improvements from the pedestrian crossing at Foster Street north to Fairgrounds Road. This provides a pedestrian connection along the west side of US-3 to Fairgrounds Road. There is a large embankment for US-3 to build up to the overpass bridge over the Tenney Mountain Highway. In order to minimize grading impacts in this area, sidewalk and granite curbing is planned to be along the roadside at the eastbound ramps. As the sidewalk continues north and the turn lanes taper back, the sidewalk should transition from the roadside to the roadway. Sidewalk planned in the roadway will still be 5 feet wide with granite curbing. There is additional pavement available from the reduced roadway section across the Tenney Mountain Highway overpass on US-3. Pavement markings could be revised in this area to reduce the painted island to include the sidewalk across the bridge, and maintain existing shoulder and lane widths. A contained drainage system already exists through this part of the corridor, basins will need to be modified to the new gutter line with the sidewalk improvements.

Constructing the sidewalk from Foster Street to Fairgrounds Road along the east side of US-3 was given strong consideration. Much of the "herd path" along US-3 is on this side of the road and there is existing granite curbing as well as a sidewalk on the east side of the US-3 overpass. Building the sidewalk on the east side of US-3 would be simpler and more cost effective. However, this alternative seems to deviate from the project scope of non-motorized safety and pedestrian connectivity. One of the major driving factors for extending the sidewalk to Fairgrounds Road is to better accommodate pedestrians from affordable housing communities on Fairgrounds Road to downtown locations. The eastern sidewalk alternative would require pedestrians to cross four lanes of pavement at Fairgrounds Road and an additional four lanes of pavement at Foster Street. Providing the sidewalk infrastructure on the west side of US-3 reduces these conflict points and provides a consistent corridor for pedestrians.

Estimated Project Costs

As requested, HEB has prepared cost estimates for both Phase 1 and Phase 2 based on the concept drawings for Multi-Modal Improvements on US-3 in Plymouth. The estimates include line items for 2023 Construction Cost (CN), 2023 Preliminary Engineering (PE), and 2023 Rights-of-Way (RW). A minor item allowance of 20% was added to the base estimate to account for items too small to quantify during the conceptual design phase. Construction Engineering costs were assumed to be 25% of the Base Estimate. Total Construction Cost (CN) includes the Base Estimate, plus Construction Engineering, plus a 10% contingency. Preliminary Engineering costs were assumed to be 20% of the CN cost; additional effort is anticipated due to scope complexity, potential historic involvement, and potential railroad coordination. This breakdown and quantity estimates are available on the attached spreadsheet.

In order to account for inflation, the Base Estimate was compounded annually at a 2.8% interest rate. Each phase was adjusted for inflation accordingly dependent on the fiscal year monies are anticipated to be obligated. Based on an assumed TYP schedule the phases were inflated to the following years: PE in 2029, RW in 2032, and CN in 2034.

HEB has prepared a preliminary Engineer's Opinion of Probable Costs (see Attachment C). Below is a summary of the proposed improvements with projected costs for each phase on the NHDOT Ten Year Plan.

Recommendations


Although the Town requested looking at these projects as two separate phases due to concerns over funding constraints, HEB feels there is enough purpose and need for non-motorized and geometric improvements within this corridor and that these scoped phases should be combined into one proposed project.

The combined proposed project scope provides safety improvements for all roadway users, creates opportunities for economic development, provides downtown connectivity to affordable housing (potential Environmental Justice communities), and encourages recreation and alternate transportation modes. Plymouth is also a major transportation junction within the region providing an eastern gateway to the Lakes and White Mountain regions, with access to I-93, US-3 and the Tenney Mountain Highway.

Governor and Executive Council Meeting Report

State House, Concord, New Hampshire March 8, 2023, 10:00 a.m.

I. <u>Highlighted Issues</u>

The full meeting agenda, quick results, and audio recordings can be found <u>here</u>. Minutes for each meeting are approved at the following Executive Council meeting.

- NATIONAL GUARD ACTIVATED AT NEW HAMPSHIRE PRISON FOR MEN. The Commissioner of the Department of Corrections notified the Executive Council that, after requesting support from the Office of the Governor, 18 members of the New Hampshire National Guard are deploying to the New Hampshire State Prison for Men in Concord as corrections officials deal with a dramatic 51% staffing shortage in entry-level correctional officer positions. The Deputy Adjunct General assured the Council that activated members of the National Guard will not be local law enforcement or emergency response officials as to not put an extra burden on municipalities.
- ELECTRIC CHARGING STATIONS IN PETERBOROUGH. The Executive Council authorized the Department of Environmental Services to enter into two grant agreements totaling \$481,193 for the installation of two electric vehicle charging stations, one of which will be in the Town of Peterborough (Item #44). This project will consist of two direct current fast chargers and one dual-nozzle level 2 alternating current charger at a gas station in town. These chargers will be operational and available to the public for 24 hours per day, 365 days per year and will operate for a minimum of 5 years.
- FINAL OPPORTUNITY: LOCAL RESTAURANT INFRASTRUCTURE INVESTMENT PROGRAM. The application period for the Local Restaurant Infrastructure Investment Program has been extended <u>until Wednesday, March 15, 2022 at 4:00PM.</u> Two restaurants in Littleton and Newport were awarded a total \$26,000 to be reimbursed for eligible equipment, infrastructure, and technology purchases made because of, or in response to, the COVID-19 pandemic. Examples of potentially eligible expenses for reimbursement include equipment or software to expand or adopt digital services such as online reservations, host-less check in, at-table payment systems, menus that help provide more flexibility and increase capacity, HVAC system updates to improve COVID-19 mitigation, and more. All local restaurateurs who continue to bear a heavy burden due to the pandemic are encouraged to apply. For more information on eligibility requirements and to obtain an application, click here.

Governor and Executive Council Meeting Report

State House, Concord, New Hampshire March 22, 2023, 10:00 a.m.

I. <u>Highlighted Issues</u>

The full meeting agenda, quick results, and audio recordings can be found <u>here</u>. Minutes for each meeting are approved at the following Executive Council meeting.

- \$15 MILLION FOR BEHAVIORAL HEALTH HOSPITAL. The Executive Council unanimously approved a \$15 million grant agreement to SolutionHealth of Bedford to develop a consolidated behavioral health hospital with approximately 120 inpatient behavioral health beds (Items#6A and #11A). This is a step in the right direction in addressing our state's on-going emergency room boarding crisis. Under this public-private partnership, SolutionHealth agrees to maintain a 72-bed designated receiving facility unit, a 24-bed in-patient child/adolescent psychiatric unit, and a 24-bed in-patient geriatric psychiatric unit for a minimum of ten years.
- ADDITIONAL BEHAVIORAL HEALTH BEDS IN THE UPPER VALLEY. The Executive Council approved a grant agreement with Mary Hitchcock Memorial Hospital in Lebanon to increase behavioral health service capacity by adding five Designated Receiving Facility beds to their hospital as an additional tool to address our state's on-going emergency room boarding crisis (Item #11B).
- COMMUNITY CENTER INVESTMENT PROGRAM APPLICATIONS OPEN. In October 2022, the Executive Council approved the acceptance and expenditure of \$20 million in federal funds to support the New Hampshire Community Center Investment Program. The application period for this program is now open, and will provide resources to build and improve community spaces across the state. Eligible applicants include New Hampshire nonprofits and municipalities. In addition to meeting all eligibility requirements, all applicants will be subject to programmatic and financial review. Awards will be made to community center projects that demonstrate specific requirements, and examples of eligible projects that could be funded include: rehabilitating / upgrading physical and outdoor programming space, facility expansion, air quality improvement and ventilation upgrades, and other investments that improve the health and safety of the community center. All are encouraged to apply.
