What is Household Hazardous Waste?

DES Definition:

Household hazardous wastes are produced when household hazardous materials are no longer wanted or needed as household products. These wastes include flammables (ex: paint thinner), caustics (ex: oven cleaner), & oxidizers (ex: bleach) that can affect a consumer's health and contaminate the soil, ground water and surface waters.



Who DO We Serve?

Lakes Region residents from our participating communities



Who asks us about HHW disposal?

- Year round residents
- Seasonal residents doing clean out
- Real estate agents
- People that have lost a relative
- New home buyers
- People selling their home
- Transfer stations referring customers





Other HHW Related Calls

- Out of season resident disposal (October - March)
- Residents from non - participating communities, even other regions.
- Small businesses
- Asbestos removal

When we receive these calls, we direct them to the best resource we can find.



Why is Household Hazardous Waste disposal important to our region?

- Our region contains 40% of the states surface waters.
- Having outlets for residents prevents illegal dumping and provides responsible disposal.
- Brings awareness to our residents.
- Our local transfer stations cannot legally take HHW. Check your transfer stations permit statues.



How Much does a cleanup cost?

According to a regional Operations Manager of a HHW disposal company:

- Cost of labor and transport for 10 - 50 gal of waste starts at \$5,000.
- Cost of material disposal - 55 gal drum of oil (\$258.60), PCB liquids 5 gal (\$287.36), PCB liquids 55gal drum (\$957.88)
- One illegal dumping has the potential to cost as much as one of our collection events.



Our Regional Collection



A. Stand CleanPak upright
B. Open CleanPak until square
C. When full, gather liner and secure with (1) 12" strip (minimum) of 3M #375 (48mm) clear plastic tape or equivalent.
D. Close CleanPak Base, latches, or flaps and secure.

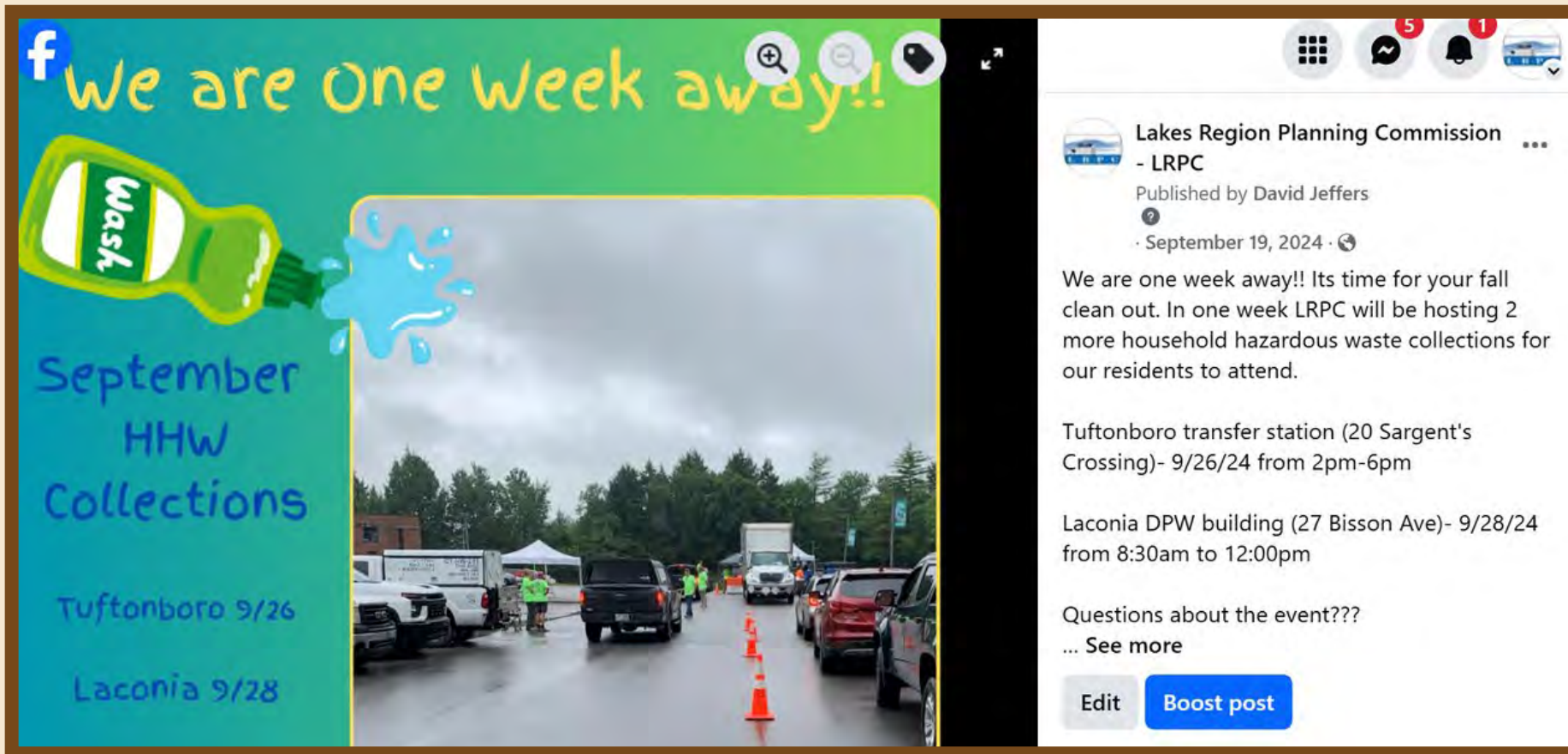

What we ask for?

- Back of the vehicle
- Organized
- 10 gal or 50 lbs of HHW
- No leaking containers





Bringing your stuff!

- 1) Traffic will line up.
- 2) Volunteers will control traffic and ask about patron residency. (We take people at their word).
- 3) Volunteers will ask about the materials patrons bring to direct the flow of traffic and conduct surveys. (oil collection, hazardous waste, unorganized materials).
- 4) Patrons will have their car trunks open for operators to remove materials. (Operators close trunks).
- 5) All acceptable materials will be removed and patron will continue through until they complete the traffic circuit without getting out of their car.
