Proposals may be submitted electronically or mailed.

Applicants must be able to conduct an interview via telephone or virtually if requested.

A. Project Description:

The Lakes Region Planning Commission (LRPC) is calling for Statements of Qualifications to provide on-call engineering services in support of transportation planning efforts throughout the Lakes Region Planning Commission's member communities. Project tasks include scoping and developing preliminary cost estimates for local Ten-Year Plan project submissions and other types of local and regional transportation planning projects that may be funded with local, state, or federal funds (including the Federal Highway Administration and Federal Transit Administration). B. Scope of Services

LRPC provides a wide variety of transportation planning services to its member communities. The primary task for the on-call engineer at LRPC is to prepare conceptual cost estimates for project proposals relating to the State of New Hampshire Ten-Year Transportation Plan. However, additional services may include, but are not limited to:

- Development and presentation of conceptual sketches, engineering designs, specifications and other planning level assistance for proposed projects,
- Drafting of project scopes of work, deliverables, timelines, and implementation details for local projects,
- Preparing preliminary cost estimates for projects and alternatives within projects,
- Meetings and or site visits with representatives of LRPC member communities and staff on an asneeded basis to discuss projects and options

All work under the overall master agreement will be assigned by individual task orders negotiated on a lump sum basis. The overall master agreement will begin no earlier than January 1, 2026, and extend through June 30, 2027. The maximum amount to be awarded under the overall master agreement is not to exceed \$60,000.

Please note that the overall amount of work assigned through task orders will depend on the volume of requests received by LRPC from its member municipalities.

C. Statement of Qualifications Requirements:

A firm, partnership, individual, etc., interested in providing on-call engineering services to LRPC must have the following qualifications and document them within their proposal:

Table 1: Checklist of Submission Requirements

Requirements

Name of the consulting firm with a brief history and description

Name, title, and professional and educational qualifications; including appropriate state licenses and affiliations of key personnel assigned to this project

List of any staff with current New Hampshire Department of Transportation (NHDOT) Local Public Agency (LPA) experience and certification

Staff shall possess significant experience in -based transportation planning/engineering

Staff shall possess demonstrated experience working with federal transportation funds

Sufficient staff and firm capacity to perform the work in an adequate and appropriate timeframe to allow for sufficient assistance to municipalities

Include a one-page executive summary demonstrating understanding of the request and the ability to complete similar type projects within time constraints

A brief description of the three most current related projects with an outline of the level of involvement

Include a list of at least three (3) professional references, including name, title, contact information, and description of product provided (if clients) or relationship (if colleagues)

Bios of staff expected to be involved in this particular contract

All statements of qualifications must be postmarked no later than <u>December 31, 2025</u> Materials postmarked after this time will not be accepted or reviewed. It is the intent of LRPC to notify the selected firm no later than <u>January 16, 2026.</u>

The expense of preparing and submitting a Statement of Qualifications is the sole responsibility of the consultant. The LRPC reserves the right to reject any or all proposals received, to negotiate with any qualified source, or to cancel in part or in its entirety this Request for Qualifications (RFQ). This solicitation in no way obligates LRPC to award a contract. Any contract awarded by the LRPC pursuant to this RFQ shall be subject to the provisions of the New Hampshire Department of Transportation's (NHDOT) Local Public Agency (LPA) Manual for the Development of Projects.

LRPC will afford firms, partnerships, or individuals' full opportunity to submit proposals in response to this invitation and will not discriminate on the basis of race, color, national origin, sex, age, or disability in consideration of this award.

Review and Selection Process:

The submissions will be reviewed by a selection committee comprised of LRPC staff using a Qualifications-Based Selection (QBS) process and criteria outlined in Table 2.

In unusual circumstances where a recommendation cannot be made based on the QBS process and selection criteria, the highest ranked consultants may be invited to a telephone or video call interview. Presentations will be allowed, with a time limit specified prior to the interview. Should interviews be held, LRPC will evaluate the interview using the criteria presented below in Table 3. Scores from the interview criteria will be added to the selection score to determine the final ranking.
